Re: FY 2023 Fringe Benefit Rates

Effective July 1, 2022 the fringe benefit rates for Fiscal Year 2023 will change to the rates indicated below. Faculty and staff should use these rates when calculating budgets that are included in sponsored projects or grant proposals to be awarded after July 1, 2022. The federal rate should be used for **formula funding only**, not competitive grants. The new fringe benefit rates are as follows:

FICA and Medicare	7.2%
Prior Period Adjustment	-0.3%
Benefits Group 3: Graduate Assistants	5.8%
<u>Includes:</u> <i>Graduate Assistants (salaried)</i>	
Components: Workers Compensation	0.2%
Medical (Graduate Assistants)	5.7%
Prior Period Adjustment	-0.1%
